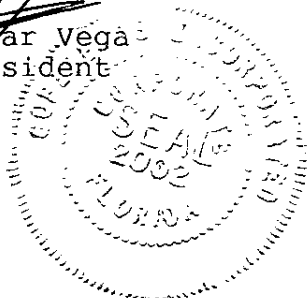
The delay to present this form and make the payment required was: the president of the corporation was out of the country for urgent reasons and he is the unique person authorized to sign this form.
