The undersigned, who is a duly licensed nurse in the State of Florida, desires to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation, adopts the following Articles of Incorporation:

NAME

The name of the professional Corporation is NICOLLE O'NEILL, CRNA, P.A.

PRINCIPAL OFFICE

The mailing address of the initial principal office of the Corporation is 1933 Beach Avenue, Atlantic Beach, Florida, 32233.

ELECTION UNDER PROFESSIONAL CORPORATION ACT

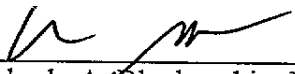
