#### a Florida corporation

#### ARTICLE I

#### <u>Name</u>

The name of the corporation is 3009 ALHAMBRA CIRCLE, CORP., a Florida corporation.

#### ARTICLE II

#### Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing upon the filing of these Articles of Incorporation with the Florida Division of Corporation of the Department of State.
