ARTICLE 1 - NAME

The name and address of this principal corporation is **CORBY HILL AUTO REPAIR INC.**, 1204 Commercial Street, Riviera Beach, Florida 33417, in Palm Beach County. The corporation is organized pursuant to the FLORIDA profit Corporation Code.

ARTICLE 2 - EXISTENCE

The duration of this corporation shall be perpetual. The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE 3 - PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida, more specifically set out as follows:

1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with an auxiliary foregoing business.

ARTICLE 8 - Voting

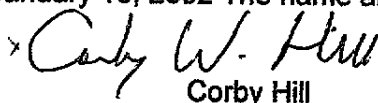
