AMENDMENTS OF ARTICLES





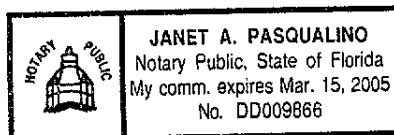
