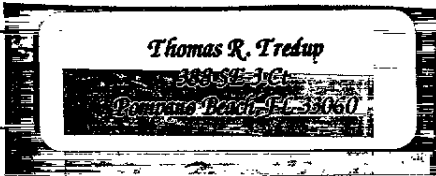

I. NAME

IX. REGISTERED OFFICE

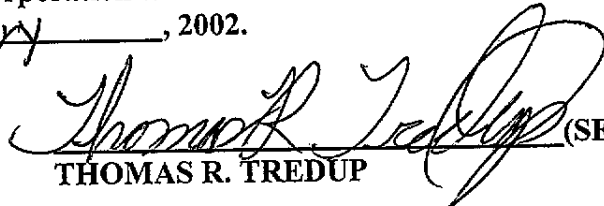

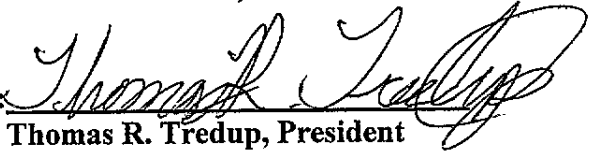

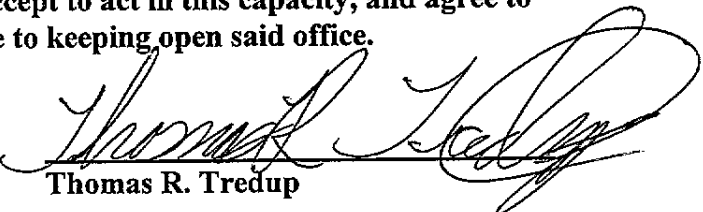
