We, the undersigned incorporators of this corporation under Florida Statute 607, as amended, adopt the following Articles of Incorporation.

ARTICLE I

Name and Principal Office

The name of this corporation is: Total Resources,
Inc. The principal office of this corporation is located
at 8628 S.W. 208 Terrace, Miami, Florida 33189.

ARTICLE II

Purposes

The general nature of the business and the objects and purposes proposed to be transacted and carried on by and powers of this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, viz:

(a) Our mission is to provide creative and cost effective business solutions to pubic and private entities. Our commodities range from Hi-Tech computer software to an array of comprehensive tangible products. We will offer resources to all industries including Government,
