- (b) To promote dental and scientific research and knowledge, to furnish related laboratory and clinical services and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of such professional services.
- (c) To do everything necessary, proper or convenient for the accomplishments of any of these purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida of the United States or by provision of these Articles of Incorporation.
- (d) To carry out the purpose of this Corporation only through officers, employees, and agents, each of whom is duly licensed or otherwise legally qualified to render professional services in the State of Florida.

ARTICLE IV

SHARES

The maximum number of stock which this corporation is authorized to issue or to have outstanding at any time shall be 10,000 shares of common stock with \$1.00 per value per share. Any other consideration to be paid for each share shall be fixed by the board of Directors.

This provisions shall be in addition to any other rights to which those indemnified may be entitled under any By-Laws, agreements, vote of shareholders or disinterested directors or otherwise, both as to action in his or her capacity and is to continue as to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors, and administrators of such a person.

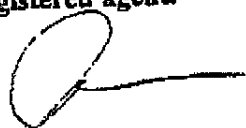
