ARTICLE I
NAME OF CORPORATION

The name of the Corporation is International Therapy, Inc.

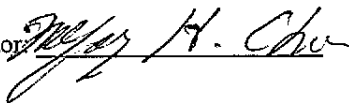

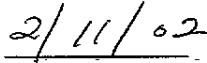
AMENDMENT
