of

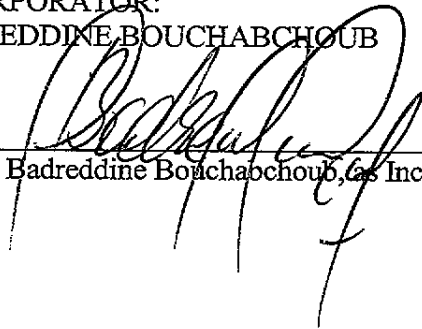

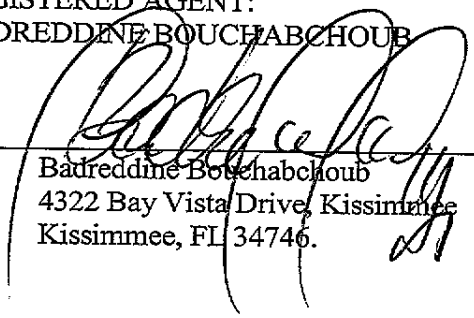
