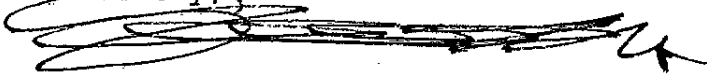

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is T-Shirt Express Body Piercing, Inc. The mailing address of the corporation is 11830 Front Beach Road, Panama City Beach, Florida 32407.

SECOND:

The corporation is to commence its corporate existence on the date of the filing of these articles with Florida Department of State, and the period of duration of the corporation is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this state.

FOURTH:

The aggregate number of shares that the corporation shall have the authority to issue is one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

FIFTH:

The address of its principal and initial registered office is 11830 Front Beach Road, Panama City Beach, Florida 32407, and the name of its initial registered agent at said address is Georges Outmezguine.

SEVENTH:

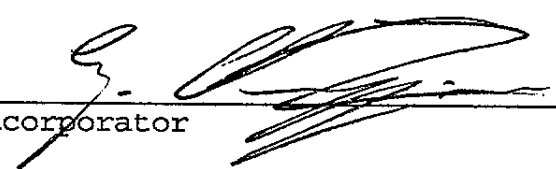

EIGHTH:

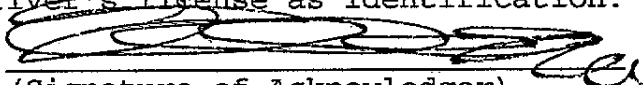

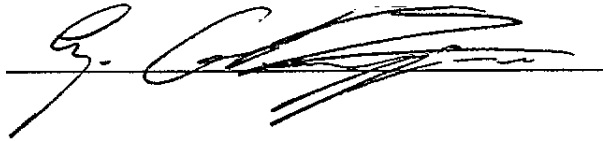
