ARTICLES OF INCORPORATION

OF

KEYS COUNTRY REALTY AND DEVELOPMENT, INC. A Florida Profit Corporation

(Pursuant to Chapter 607 and 621, Florida Statutes)

The undersigned person has signed this document for the purpose of forming a corporation under the laws of Florida and adopts the following Articles of Incorporation.

- 1. <u>Name.</u> The name of this corporation is **Keys Country Realty and Development**, Inc.. The period of duration shall be perpetual.
- 2. <u>Purpose and Powers.</u> This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time. No other purpose limits this general purpose in any way.

This corporation shall have the broad general powers set forth in s. 607.0302, Florida Statutes, and the purpose for which this corporation is organized is:

Any and all Legal Business

- Authorized Capital. The corporation shall have the authority to issue 1000 shares of common stock. All shares shall be voting shares.
