**ARTICLES OF INCORPORATION
OF
CHOICE CELLULAR OF ORLANDO, INC.**

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.
Name**

The name of the Corporation is **Choice Cellular of Orlando, Inc.**

**II.
Term of Existence**

The date when corporate existence will commence is February 20, 2002 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

The principal office and mailing address of the Corporation is 3800 Tampa Road, Oldsmar, Florida 34677.

**IV.
Capital Stock**

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

**V.
