ARTICLES OF INCORPORATION OF NEXUS ENTERTAINMENT, INC.

The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation shall be NEXUS ENTERTAINMENT, INC.

ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 120 E. Concord Street, Orlando, Florida 32801.

ARTICLE III-DATE OF EXISTENCE
