SECRETARY OF STATE TALLAHASSEE ACPRIDA hereby adopts the following Articles for such corporation.

ARTICLE I

The name of the corporation shall be W.T.C. International Inc.

ARTICLE II

The period of duration of the corporation is perpetual.
