2. **Article VII** of the Articles of Incorporation relating to the initial directors is hereby amended to read as follows:

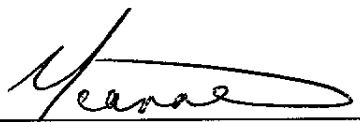
