

To whom it may concern in The Division of Corporations,

I, George J. Frederick am writing to you to have my Corporation reinstated. On July 27, 2004 I had made a phone call into the Division of Corporations, I stated that I would like to have F3 Financial Merchants, Inc. reinstated, and what was the necessary steps that I needed to take. It was explained to me that I would have to fill out a Corporation Reinstatement form, and pay for a reinstatement fee of \$600, then \$61.25 for each annual report (which would be two), and a Corporate Supplement Fee of \$88.75 for each year the Corporation was dissolved. My Corporation was dissolved in Sep. of 2003. Now, the reason for my letter is that I was also informed that a notice to dissolve was sent to me. I never received this letter, but, it was also show on your computer that is was sent out, and it was sent back to the Division of Corporations as not received, and return to sender. So, I was told to write a letter explaining what had happened, to have the \$600 reinstatement fee waived. I am enclosing a check for two annual statement fees, one Corporation supplemental Fee (for each year corporation dissolved), and also a Certificate of status fee, Totaling \$220.00 Dollars.
