#### ARTICLES OF INCORPORATION

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business

Corporation Act, hereby adopts the following Articles of Incorporation in compliance with Chapter 607/ARY OF STATE and/or Chapter 621, F.S. (Profit)

#### ARTICLE I - NAME

The name of the corporation shall be: D&S Software, Inc.

#### ARTICLE II - PRINCIPAL OFFICE

#### Participation

- Subject to the rights and privileges attached to other classes of shares, holders of Class "A" Common Voting shares shall have the right:
  - o to participate in the property, profits, and surplus assets of the Corporation and, for that purpose, to receive any dividend declared by the Corporation; and
  - o to receive the remaining property of the Corporation on dissolution

### Restrictions

No dividend or distribution of any kind whatsoever shall be declared or made in respect of the
Class "A" Voting shares which will have the effect of reducing the net assets, including goodwill,
of the Corporation to an amount insufficient to enable repurchase of redemption by the
Corporation of all of any Preferred shares issued and outstanding.

#### Public Subscription

• Any invitation to the public to subscribe for securities of the Corporation is prohibited.

#### Restrictions on Share Transfers

• No Share of the capital of the corporation shall be transferred without the sanction of a majority of the Directors of the Corporation.
