ARTICLES OF INCORPORATION OF YORKSHIRE CORPORATION

ARTICLE I NAME

ARTICLE VIII VOTING REQUIREMENTS FOR SHAREHOLDERS

Further, the power to adopt, alter, amend or repeal the By-Laws shall be vested in the Board of Directors of this Corporation.

ARTICLE XI POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida Business Corporation Act, as amended from time to time.

ARTICLE XII DIVIDENDS

Dividends payable in shares of any class may be paid to the holders of shares of any other class.

ARTICLE XIII INDEMNIFICATION
