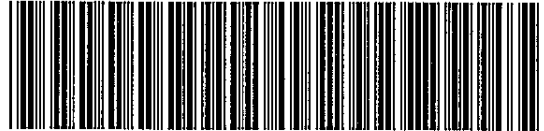

FOURTH: The amendments were adopted by the incorporators or board of directors without shareholder action and shareholder action was not required.


