**ARTICLES OF INCORPORATION OF FRANCIS M. CURRAN, P.A.**

I, the undersigned, make subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a professional services corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I – NAME**

The name of this professional service corporation shall be FRANCIS M. CURRAN, P.A., the principal place of business shall be 581 South Duncan Avenue, Clearwater, Florida, 33756, and the mailing address shall be P.O. Box 5941, Clearwater, Florida 33758-5941.

**ARTICLE II – NATURE OF BUSINESS AND POWERS**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, including but not limited to the rendition of professional services by a member or members of The Florida Bar and other services commonly performed as an incident thereto.

**ARTICLE III – CAPITAL STOCK**

The amount of capital stock authorized shall consist of one thousand (1,000) shares of common voting stock having a par value of \$-0- per share payable in lawful money of the United States of America or in other property, tangible or intangible, but not in labor services or stock, at a just valuation to be fixed by the Board of Directors, or issued as partly paid when so ordered by the Board of Directors. The capital stock of the corporation may at any time be increased or decreased as provided by the laws of Florida.

#### **ARTICLE IV – PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

#### **ARTICLE V – TERM OF EXISTENCE**

This corporation shall have perpetual existence unless sooner dissolved according to law, commencing upon the filing of these Articles of Incorporation with the Department of State of the State of Florida.

#### **ARTICLE VI – REGISTERED AGENT**

The name and Florida street address of the registered agent of the corporation is Francis M. Curran, 581 South Duncan Avenue, Clearwater, Florida, 33756.

#### **ARTICLE VII – BOARD OF DIRECTORS**

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by bylaws adopted by the shareholders, but shall never be less than one.

#### **ARTICLE VIII – INITIAL DIRECTORS**

The name and street address of the initial director is Francis M. Curran, 581 South Duncan Avenue, Clearwater, Florida, 33756.

#### **ARTICLE IX – ACTION WITHOUT MEETING**

Action taken by the Board of Directors without a meeting shall nevertheless be Board action if written consent to the action in question is signed by all of the Directors

and filed with the minutes of the proceedings of the Board, whether done before or after the action so taken.

#### **ARTICLE X – INCORPORATOR**

The name and street address of the person signing these Articles is Francis M. Curran, 581 South Duncan Avenue, Clearwater, Florida, 33756.

#### **ARTICLE XI – SUBSCRIBERS**

The name and street address of the subscriber is Francis M. Curran, 581 South Duncan Avenue, Clearwater, Florida, 33756, and he agrees to take 1,000 shares.

#### **ARTICLE XII – OFFICERS**

Francis M. Curran, 581 South Duncan Avenue, Clearwater, Florida, 33756, shall be president and secretary/treasurer, and shall act as such until his successors have been chosen and duly qualified.

#### **ARTICLE XIII – OFFICERS AS DIRECTORS**

All officers of the corporation may be directors.

#### **ARTICLE XIV – POWERS OF DIRECTORS**

The Directors shall have the power to hold their meetings and to hold one or more offices and keep the books and records of the corporation, except the original or duplicate stock ledger, outside the State of Florida, at such place or places as from time to time may be designated in the By-Laws or resolutions of the Board of Directors. Members of the Board of Directors may participate in regular meetings of the Board of Directors by means of conference telephone as provided by law.

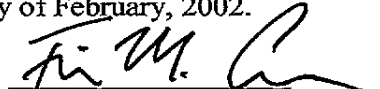
**ARTICLE XV – INDEMNIFICATION**

The corporation shall indemnify any officer or director, or former officer or director, to the full extent permitted by the law.

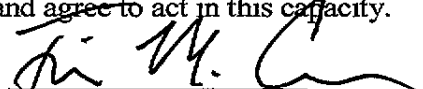
**ARTICLE XVI – AMENDMENT**

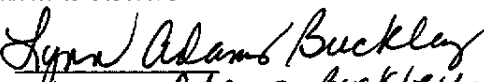

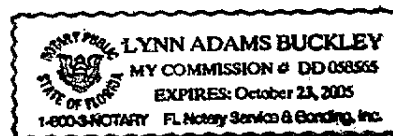
