ARTICLES OF INCORPORATION
OF
GULF COAST PHARMACEUTICAL RESEARCH, INC.

We, the undersigned incorporators, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be GULF COAST PHARMACEUTICAL RESEARCH, INC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal office and address of said corporation is 7320 State Road 52, Hudson, Florida 34667.

ARTICLE III. PURPOSE

The purpose of this corporation is for services related to pharmaceutical research, together with any and all business related thereto, and the transaction of any and all lawful business, both domestic and abroad for which corporations may be organized under Florida Statute 607.

ARTICLE IV. CAPITAL STOCK

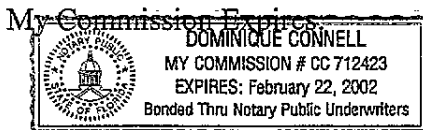


