ARTICLES OF INCORPORATION OF GULF COAST PHARMACEUTICAL RESEARCH, INC.

We, the undersigned incorporators, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be GULF COAST PHARMACEUTICAL RESEARCH, INC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal office and address of said corporation is 7320 State Road 52, Hudson, Florida 34667.

ARTICLE III. PURPOSE
