

ARTICLES OF INCORPORATION

OF

GEN - X ROOF CLEANING OF FLORIDA, INC.



ARTICLE I

The name of this corporation is: GEN - X ROOF CLEANING OF FLORIDA, INC.

ARTICLE II

The initial registered office in the State of Florida is located at 4241 Cloverleaf Place, in the City of Casselberry, County of Seminole. The registered agent in charge thereof is William L. ARTICLE VIII

The Officers of the Corporation are as follows:

PRESIDENT - WILLIAM L. GANN, JR.
EXECUTIVE VICE-PRESIDENT - KELLY B. CARR
TREASURER - JOHN R. GANN
SECRETARY - KELLY B. CARR

The mailing addresses of the above listed officers are the same as listed in Article VII above.

ARTICLE IX

The directors shall have power to make and to alter or amend the bylaws; to fix the amount to be reserved as working capitol; and to authorize and cause to be executed mortgages and liens without limit as to the amount upon the property and franchise of the Corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capitol stock issued and outstanding, the directors shall have the authority to dispose in any manner of the whole property of this Corporation.

The bylaws shall determine whether and to what extent the accounts and books of this Corporation or any of them, shall be open to the inspections of the Shareholders; and no shareholder shall have any right of inspecting any account or book or document of this Corporation, except as conferred by the law or the bylaws, or by resolution of the shareholders.

The shareholders and directors shall have power to hold there meetings and keep the books, documents and papers of the Corporation within or without the State of Florida, at such places as may from time to time be designated by the bylaws or by resolution of the Shareholders or Directors except as otherwise required by the laws of the State of Florida.

It is the intention that the objects, purposes and powers specified in the third paragraph hereof shall except where otherwise specified in said paragraphs, be nowise limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles of Incorporation, but that the objects, purposes and powers specified in the third paragraph and in each of the clauses or

paragraphs of this Charter shall be regarded as independent objects, purposes and powers.

ARTICLE X

The Directors of the Corporation shall not be liable to either the Corporation or it's Shareholders for monetary damages for a breach of fiduciary duties unless the breach involves: (1) a directors duty of loyalty to the Corporation or it's Shareholders; (2) acts or omissions not in good faith or which involve intentional misconduct or knowing violation of law; (3) liability for unlawful payments of dividends or unlawful stock purchases or redemption by the Corporation; or (4) a transaction from which the director derived an improper personal benefit.

I, the undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, do make, file and record these Articles of Incorporation and Certify that the facts herein are true and correct; and I have hereunto set my hand in seal.
