

INDEMNIFICATION OF OFFICERS AND DIRECTORS





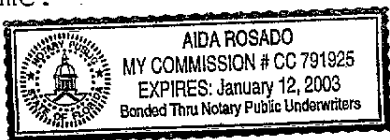
