ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is Perser Co.

The principal place of business of this corporation shall be: 9 SW 13th Street, Fort Lauderdale, FL 33315

ARTICLE II: DURATION
