## ARTICLES OF INCORPORATION

OF

## MICHAEL BOURASSA CONSTRUCTION CO., INC.



The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

- Article 1. Name and Address: The name of the Corporation is: MICHAEL BOURASSA CONSTRUCTION CO., INC.. The principal office and mailing address of the Corporation is: 551 South Brevard Ave., #309, Cocoa Beach, Florida 32931.
  - Article 2. Duration: The duration of the Corporation is perpetual.
- Article 3. Purpose: The general purposes for which the Corporation is organized are the following:
  - A. To engage in and transact any lawful business for which corporations may be incorporated under the laws of the State of Florida. No other purpose limits this general purpose in any way.
  - B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
