ARTICLES OF INCORPORATION

OF

BPR Data Mining, Inc.

ARTICLE - I

The name of this corporation is: **BPR Data Mining, Inc..**

ARTICLE - II

The purpose of this corporation is to prepare custom software programming for use in businesses, and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE IV - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

ARTICLE V - INITIAL REGISTERED
