**ARTICLES OF INCORPORATION  
OF  
HUNDRED FOOT SKY, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation.

**ARTICLE ONE**

The name of the corporation is HUNDRED FOOT SKY, INC. The principal place of business and business address is 23312E SW 53rd Ave, Boca Raton, FL 33433

**ARTICLE TWO**

The duration of the corporation is perpetual.

**ARTICLE THREE**

The purposes for which the corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act.
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
3. To design, manage, operate and market web sites and provide other related internet, design and marketing services.
