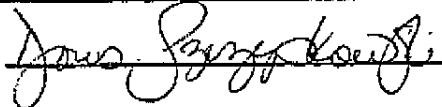
**Article 11 - Director Liability**

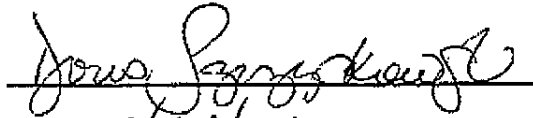
