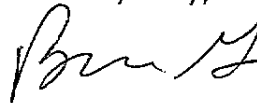

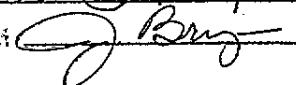

ARTICLES OF INCORPORATION

OF

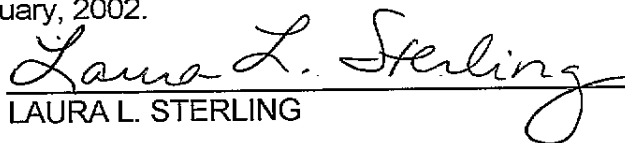
ARTICLE VIII - BYLAWS
