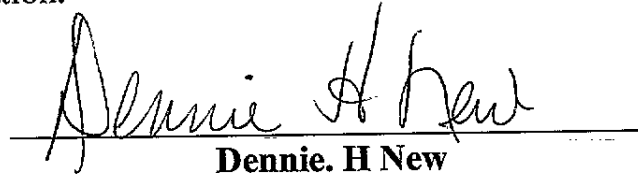
ARTICLE V

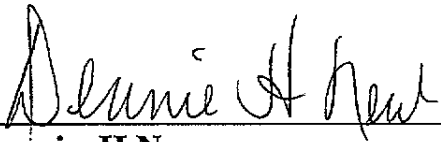

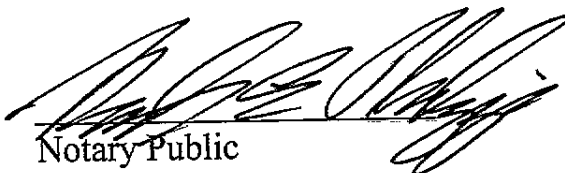
