Name

The name of the Corporation is EL&K Transport, Inc., herein referred to as the "Corporation."

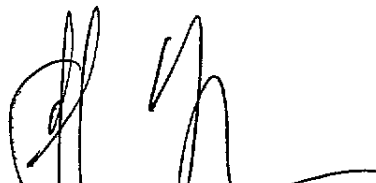
