CECHEROS PHILES The undersigned subscriber to these Articles of Incorporation, Sergio Petruzzella, being natural person competent to contract, hereby acknowledges and files theses ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes does hereby adopt the following Articles of Incorporation.

ARTICLE I

CORPORATE NAME

The name of this professional service corporation is Ital Design Tile & Marble Inc. The principal and mailing address of the corporation is 10184 Boca Circle, Naples, Fl. 34109

ARTICLE II

<u>DURATION</u>

This professional service corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.
