

To the Reinstatement Board,

I honestly do not know where to start. I am very embarrassed at the situation my company is in and would like to have your help to rectify it.

Last year, we received a Notice Of Administrative Dissolution Or Revocation. I called the telephone # listed and had said that we did not receive any notices before this one. We were directed to write a letter explaining the situation and send that letter along with a check for \$150.00 for review. I gave the letter to my Office Manager along with the information of how to proceed. I did not follow up and was under the impression that all was okay. Without my knowledge, the Office Manager mailed the form and check for \$150.00, however did not in close the letter that had been written. A response was mailed back to us and required a signature from the Registered Agent and an additional fee of \$600.00.
