**ARTICLE I. CORPORATION NAME**



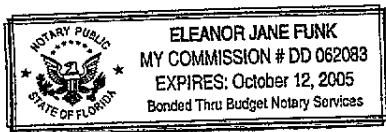
