ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: N & D RELOCATIONS, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on February 19, 2002.


