ARTICLE - I

The name of this corporation is: EMERGENCY RESPONSE COMPANY, INC.

ARTICLE - II

The purpose of this corporation is to sell new and refurbished electrical supplies and equipment, and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock
