ARTICLE I

NAME

ARTICLE II INITIAL PRINCIPAL OFFICE

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock with par value of One Dollar (\$1.00) each that the corporation is authorized to have outstanding at any time is 5,000 shares.
