The undersigned, George Jenkins and Gregory Burkhardt, do hereby become a corporation under the Laws of The State of Florida by making, subscribing, and acknowledging and filing in the Office of the Secretary of State, the following certificate and we do hereby certify that:

ARTICLE I

NAME

ARTICLE II

INITIAL PRINCIPAL OFFICE

The principal office of the Corporation shall be at 612 Woodsman Dr.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock with par value of One Dollar (\$1.00) each that the corporation is authorized to have outstanding at any time is 5,000 shares.

ARTICLE VIII



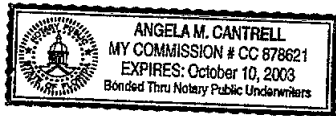


