**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is REMODELING MASTERS, INC., and the principal address and principal place of business is 14126 WHISPERWOOD DRIVE, CLEARWATER, FLORIDA 33762.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
