**ARTICLES OF INCORPORATION  
of  
Images of Courage, Inc.**

The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a business corporation under the laws of the State of Florida.

**ARTICLE 1**

**The name of the corporation shall be:  
Images of Courage, Inc.**

**ARTICLE 11**

The existence of the corporation shall be effective February 22, 2002 notwithstanding the earlier filing date of these Articles of Incorporation with the Secretary of the State of Florida, and its existence shall be perpetual.

**ARTICLE 111**

The general business the corporation may engage in is the developing and marketing of various images of sculpture and photography permitted by the laws of the State of Florida. The corporation shall have all the powers vested in a corporation organized under and existing by virtue of such laws.

**ARTICLE 1V**

The aggregate number of shares which the Corporation shall have authority to issue shall be 1,000,000 shares of common stock with a par value of \$0.001 per share.

**ARTICLE V**

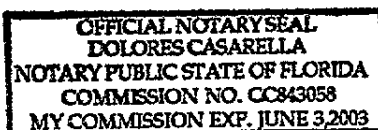
