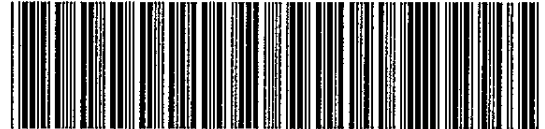

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*


**ARTICLE I:** The name of the corporation shall be amended to:
