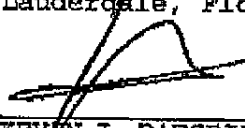
ARTICLE VIII - BYLAWS

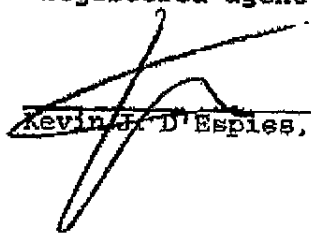
