In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is NAK TRANSPORTATION SERVICE, INC.

ARTICLE II

The existence of the Corporation shall begin on the date of the filing of the Articles of Incorporation.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares.
