2. The general nature of the business to be transacted shall be to have all other powers provided by the laws of the State of Florida.



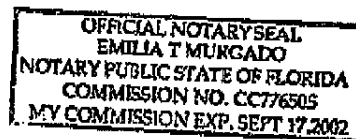
