**ARTICLES OF INCORPORATION**

**OF**

**Olive Branch Resale Shop, Inc.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is:

**Olive Branch Resale Shop, Inc.**

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**

The corporation may engage in any activity or business as permitted under the laws of the United States and the State of Florida but only through its officers, employees, and agents who are duly licensed or authorized to render such business.

**ARTICLE IV**

The amount of capital stock of this corporation shall be TEN THOUSAND SHARES (10,000) at One Dollar (\$1.00) par value per share. Such stock shall be non-assessable to be held, sold and paid for at such time and in such manner as the Board of Directors may, from time to time, determine. All of the capital stock shall be common stock.

**ARTICLE V**

The corporation shall commence business five (5) business days prior to the filing with the Secretary of State.

#### ARTICLE VI

The principal place for the transaction of its business shall be 225 29th Avenue N., St. Petersburg, FL 33704. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida, as the corporation may by resolution designate.

#### ARTICLE VII

The corporation shall have an initial Board of one (1) Director, and the Board may be increased to not more than ten (10) Directors. The number of Directors each year may be determined by the shareholders at their annual meeting, or may be fixed by the By-Laws.

#### ARTICLE VIII

The officers by whom the business of said corporation shall be conducted shall be a President, who shall be a Director and a Vice-President, a Secretary and a Treasurer, and such other officers, agents and Directors, who shall be chosen in such manner, hold their office for such term and have such powers and duties as may be prescribed by the By-Laws or determined by the Board of Directors. The name and post office address of the officers and first Board of Directors who shall conduct the business of the corporation until their successors are elected and qualified following the first meeting of shareholders shall be:

## ARTICLE X

The Directors shall be elected by shareholders at their annual meeting, and the officers shall be elected by the Directors at their annual meeting, both of which will be held at the principal office of the corporation, or at such other place as may be provided by the By-Laws, or may otherwise be agreed upon.

## ARTICLE XI

The street address of the initial registered office of this corporation is 225 29th Avenue N., St. Petersburg FL, 33704, and the name of the initial registered agent of this corporation at that address is Gloria Klein.


## ARTICLE XII

## ARTICLE XIII

The Directors may not alter, amend or repeal any By-Law which would be in conflict with the By-Laws adopted by the shareholders.
