ARTICLES OF INCORPORATION
OF

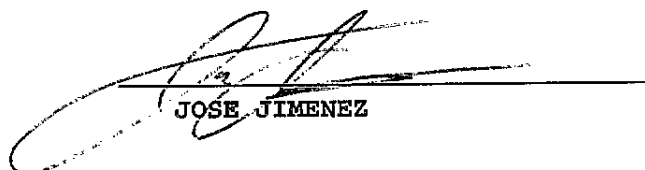
ARTICLE IX - INDEMNIFICATION

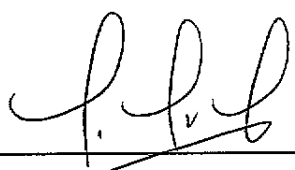

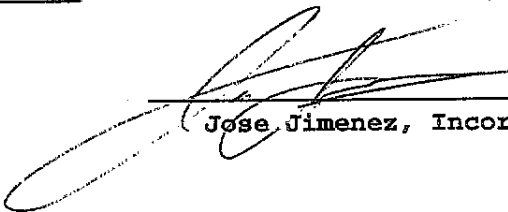
