The name of the corporation is VIOLENCE INTERVENTIONS & PREVENTION TRAINING, INC. The principal address of the corporation is: 245 NW 117th Ave, Coral Springs, Florida 33071.

The period of its duration is perpetual.

ARTICLE THREE
