

#### ARTICLES OF INCORPORATION OF BUTTERFLY DISPLAY, INC.

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following 18 1 PH 1:00 Articles of Incorporation for such Corporation:

# ARTICLE I
